- Signed invitation letter (not older than 6 months) in Czech or English in free form. It must include details of the inviting person (name, address and contact information, date of birth) and the following information of the invited person: name, date of birth, address and contact information, purpose and length of visit, mentioning if the guest is a relative, friend etc.
- A copy of the inviter's passport or Czech ID and/or the valid residence permit, if non-Czech inviter.
- Proof of the existence of relationship*
- Proof of means of subsistence (Bank account statement on the account turnover during the last six months)
- Proof of regular income e.g. salary, slips of the last six months
- Flight Reservation or vehicle Reservation/ Uçuş Rezervasyonu ya da araç rezervasyonu

Furthermore, if at the time when the application is lodged, it cannot be immediately confirmed that the fingerprints were collected, the applicant may request that they be collected.
