INDIVIDUALS WHO HAVE RIGHT OF OWNERSHIP OF REAL PROPERTY

Application should be submitted at the local Visa Facilitation Center VFS: Georgia visa application center.

The visa application form should be submitted in an electronic form through official website. www.geoconsul.gov.ge

Please submit the documents in exact order given below; please do not staple any document	
Online Visa Application Form completed, signed by the applicant & if applicable: Authorization (for 3rd person). In case applicant is a minor: Visa application signed by legal guardian & if applicable: Authorization (for third person) – Visa Application Form must be filled in BLOCK Letters.	<input type="checkbox"/>
Travel Document issued within the last 10 years and the validity period of the travel document shall exceed the validity period of the visa by at least three months; it shall not be damaged and shall not contain unofficial records; it shall contain at least two empty pages to place a visa blank in	<input type="checkbox"/>
A document evidencing payment of a visa fee determined 20USD	<input type="checkbox"/>
A document evidencing the purpose of travel – in the territory of Georgia; a document certifying title to real property (except for agricultural land) located in Georgia, the value of which exceeds USD 35 000 equivalent in GEL – an extract from the Public Register and a document issued by a certified assessor of the body accredited by the Legal Entity under Public Law – the Unified National Body of Accreditation of Georgia - Accreditation Centre, Which confirms the market value of the real property.	<input type="checkbox"/>
In the case of a guardian/custodian of a citizen of Georgia, or in the case of a person under guardianship/ custody of a citizen of Georgia – a document evidencing guardianship and custodianship.	<input type="checkbox"/>
A document evidencing payment of the penalty if an alien was imposed a penalty under the legislation of Georgia for staying in Georgia without legitimate grounds.	<input type="checkbox"/>
To issue a visa to a minor (under 18) and/or a person with mental disorders – the consent of legal representative/representatives of the minor and/or the person with mental disorders along with Birth Certificate needs to be submitted. Important : Affidavit/Consent letter, Birth & Marriage Certificates must to be Notary attested and Apostilled from MEA (Apostille validity must be within 06 months from the date of issue)	<input type="checkbox"/>
