	<p><b>Original passport and passport copy including previous Schengen visas.</b></p> <p>Note: The passport must be valid for at least 6 months from the date of visa issuance. For new passports, the old passport is also required.</p>	
	<p><b>Copy of Kuwait residence permit (for Non-Kuwaiti) and Civil ID copy.</b></p> <p>Note: Residence permit should be valid for 6 months from the Schengen exit date.</p>	
	<p><b>1 recent colored passport-sized photograph in compliance with ICAO standards.</b></p> <p>Note: Photo must be recent (not older than 6 months) with white background and of good quality.</p>	
	<p><b>Copy of confirmed return airline/flight ticket with booking reference.</b></p> <p>Note: If travelling to other Schengen areas/countries, flight vouchers for all destinations must be submitted. Applicant may be asked to submit the proof of payment.</p>	
	<p><b>Copy of the marriage certificate and/or family certificate.</b></p> <p>Note: The certificates provided must be issued from Greece (in case of Greek citizens' family members) or from the relevant EEA/EU member state (in case of EEA/EU citizens' family members). In the last case, if they are not in English, they must be translated in English with a copy of the original document attached.</p>	
	<p><b>Original or certified copy of passport of the EU/EEA citizen.</b></p>	
	<p><b>Support letter from the EU/EEA citizen.</b></p>

- The visa must be applied for either in person or through a representative.
- All documentation must be submitted in English.
- For children registered in a parent's passport, a separate application form has to be submitted.
- Original documents must be presented; additional photocopies may be required
- The Embassy of Greece has a right to ask any other **additional documents** it deemed necessary, or may call the applicant for an interview. If the visa application is refused, the reason will be provided in the refusal form. No further explanation will be given to the applicants. In all cases the visa fee and service fee is non-refundable.
- Head coverings is not permitted except for religious reasons, but facial features from bottom of chin to top of forehead and both edges of applicant's face must be clearly shown.

	<b>Copy of confirmed return airline/flight ticket with booking reference.</b> Note: If travelling to other Schengen areas/countries, flight and hotel vouchers for all destinations must be submitted. Applicant may be asked to submit the proof of payment.	
	<b>Copy of the marriage certificate and/or family certificate.</b> Note: The certificates provided must be issued from Greece (in case of Greek citizens' family members) or from the relevant EEA/EU member state (in case of EEA/EU citizens' family members). In the last case, if they are not in English, they must be translated in English with a copy of the original document attached.
