<ul style="list-style-type: none"> ○ Valid and recognised passport ○ +Not older than 10 years + still 3 months valid after return + 2 empty visa pages ○ Copy of the passport data page ○ Copies of previous visas with entry-exit stamps ○ Non Lebanese nationals residing in Lebanon: Copy of residence permit valid upon return to Lebanon – work permit.

<p>Travel health insurance (<i>Family members of EU/EEA/CH citizens are exempted</i>):</p> <ul style="list-style-type: none"> ○ Valid for all Schengen countries ○ Minimum coverage 30.000 euros & repatriation
