1	Passport	Must have a validity of at least 3 months prior to the returning date and 2 blank pages. *** see note for Foreign Nationals at bottom

3	Colour ID Photos (x2)	Can be taken at VFS for an additional fee (check Value added services)

6	Proof of Transport (C) Proof of Transport (D)	Ticket / Booking proving the arrival into and out of Schengen, into and out of Italy and all other booked internal transfers or modes of transport. Ticket / Booking, or other mode of transport, proving the arrival into Italy.			
7	Travel Insurance (LS)	Must be: - valid for the entire Schengen area - valid for the duration of the stay; - cover for a minimum of 30.000 Euros; For long stays a minimum 30-day policy is necessary awaiting for the registration of the residence permit.			
8	Proof of Accommodation	In the form of confirmation of payment for accommodation for the whole duration of the stay in Schengen or letter from the host confirming accommodation and details (see Dichiarazione di Alloggio form)			
9	Proof of Funds	Must be proven by providing a 3 months' bank statement confirming the availability of funds in Rands with a minimum equivalent of 30 Euros per day for the duration of the stay, in excess of the confirmation of accommodation.			

10	Proof of Registration within the Institution / University in Italy	Declaration by the Institution/University confirming the acceptance of registration. Proof of payment for the course			
11	Proof of Residence in SA	In the form of a utility bill or bank statement.			
12	Proof of payment	Copy of the VFS's receipt.			

ADDITIONAL DOCUMENTS REQUIRED FOR MINORS

13	Confirmation status of student	Letter of confirmation from School, College, or University			
14	Unabridged birth certificate	In which the names of both parents appear.			
15	Parental Consent Form	Both parents must sign the consent letter in front of the VFS employee. In the case of parents travelling with the minor, already holding a valid visa, a copy of the visa should be enclosed.			
16	ID/Passport of both parents	The Copies must be certified			

**** Please ensure that you are applying at the correct Jurisdiction which is determined by your city/place of Residence and not the Nationality of passport holder (check the website for more information)**

***** For NON-SA Passport holders, the passport must have a validity if at least 6 months from date of return and a copy of Original valid South African permit (permit must also be valid for at least 6 months from the date of return).**
