One Visa Application duly filled out and signed. Electronic Visa Application		
One color photograph (size 35mm x 45 mm), taken in the last 6 months, white background.		
Passport with a period of validity extending at least three months after the intended date of departure from Latvia or other Member State, containing at least two blank pages, and issued within the previous ten years.		
Copies of the identification pages and the pages containing information about previously issued visas and entry/exit stamps of the current and previous passports. In addition – for Egyptians: the <i>Mogamma</i> (movement) certificate.		
Proof of the family ties and marital status (for Egyptians: an extract of the <i>Kid Aely</i>).		
Trip itinerary.		
Original personal bank account statement with an official bank stamp and signature and translations of the statements, showing activity over last 6 (six) months. In the absence of bank account, proof of other assets has to be provided.		
For employees: <ul style="list-style-type: none"> – a certificate of employment, specifying the recruitments date, position and salary; – confirmation of leave approval. For company owners: <ul style="list-style-type: none"> – original of the commercial registry and tax card. For students: <ul style="list-style-type: none"> – proof of enrollment in school/university. 		
Proof of intended means of transport – round flight ticket or reservation indicating the complete itinerary of the tour.		
Proof of accommodation – confirmed hotel reservation in Latvia with a booking number.		
For minors, if travelling without their legal guardian(s): <ul style="list-style-type: none"> – consent of the legal guardian(s); – a copy of minor's birth certificate and translation; – a copy of each legal guardian(s) passport. For minors, if travelling with only one of their legal guardians: <ul style="list-style-type: none"> – consent of the legal guardian not travelling; – a copy of minor's birth certificate and translation; – a copy of each legal guardian(s) passport. 		
Travel assistance policy of a duration equal to that requested for visa, valid for all the countries of the Schengen area, that covers the medical expenses and of repatriation in case of accident or disease (minimum coverage: € 30.000)		

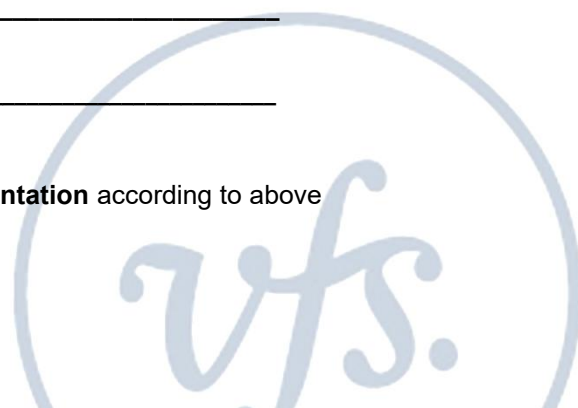
