	Copies of the passports of both parents (personal detail and signature page)
	If applicable: Proof of custody or guardianship (e.g. court order)
	 se note: The visa application cannot be submitted more than 6 months prior to departure and has to be lodged not later than 15 calendar days before the intended start of the trip. Otherwise the application is inadmissible. Submitting the above documents does not guarantee a visa. The Embassy may request a personal interview or

- further documentation.
