1.	<p> Visa application form: The form is available online at <https://formulario-mre.serpro.gov.br>. A separate form must be completed for each applicant. Once filled out, the form should be printed and signed. </p> <p> Please note: The signature on the Visa Application Form Receipt – RER receipt must match the applicant’s signature on his/her passport. Additionally, when filling out the online form, any information originally in Chinese characters (e.g., names, addresses) must be entered using Pinyin/Latin letters, not Chinese characters. </p> <p> If the applicant is under 18 years of age, both parents/legal guardians must sign the Visa Application Form Receipt – RER on the applicant’s behalf. </p> <p> 签证申请表：该表格可在 <https://formulario-mre.serpro.gov.br> 在线获取。每位申请人必须填写一份单独的表格。填写完毕后，应打印表格并签名。 </p> <p> 请注意：签证申请表收据上的签名 - RER 收据必须与申请人在护照上的签名一致。此外，在填写在线表格时，任何原始中文汉字信息（例如姓名、地址）都必须使用拼音/拉丁字母输入，而不是中文汉字。 </p> <p> 如果申请人未满 18 岁，父母双方/法定监护人必须代表申请人签署签证申请表收据 - RER。 </p>			
2.	<p> Original passport. The passport must be signed and have at least two blank visa pages. Previous passports, whenever available, are not essential documents, but their submission is encouraged as it can assist in the analysis by consular authorities; </p> <p> Please note: a minimum of six-month validity of the passport is not a requirement for issuing the visa, but is a common requirement by airline companies for those travelling to Brazil. </p> <p> 护照原件。 护照必须签名并至少有两页空白签证页。旧护照（如果有）不是必要的文件，但建议递交，以便帮助使领馆进行签证审核； </p> <p> 请注意：护照的有效期至少为六个月不是签发签证的要求，而是航空公司对前往巴西的旅客的常见要求。 </p>			
3.	<p> One recent photograph not older than 6 months, size 4cm x 5cm, in color, front view, white background. </p> <p> 一张不超过 6 个月的近期照片，尺寸 4 厘米 x 5 厘米，彩色，正面照，白色背景。 </p>			
4.	<p> Certificate of criminal records issued within the past 90 days and duly apostilled. </p> <p> 过去 90 天内签发并经过海牙认证的无犯罪记录证明。 </p>			
	<p> Legal document proving the relationship between applicant and his/her parents and its translation in Portuguese or English (e.g. </p>			

5.	<p>Birth Certificate issued by hospital or Police; Hukou; relationship certificate or other equivalent legal document etc.).</p> <p>Please note: certain hypotheses of VITEM IX, such as investment in real estate and investment in startups, require previous authorization of residence by the Ministry of Justice and Public Security. Only after such authorization is granted can the Embassy or the Consulate proceed with the analysis of the visa request.</p> <p>证明申请人与其父母关系的法律文件及其葡萄牙语或英文翻译件（例如由医院或警方签发的出生证明；户口；关系证明或其他同等法律文件等）。</p> <p>请注意：VITEM IX 的某些情况下，例如投资房地产和投资初创企业，需要事先获得司法和公安部的居住许可。只有在获得此类授权后，大使馆或领事馆才能继续签证申请。</p>
