1.	<p>Visa application form: The form is available online at <https://formulario-mre.serpro.gov.br>. A separate form must be completed for each applicant. Once filled out, the form should be printed and signed.</p> <p>Please note: The signature on the Visa Application Form Receipt must match the applicant's signature on his/her passport. Additionally, when filling out the online form, any information originally in Chinese characters (e.g., names, addresses) must be entered using Pinyin/Latin letters, not Chinese characters.</p> <p>If the applicant is under 18 years of age, both parents/legal guardians must sign the Visa Application Form Receipt – RER on the applicant's behalf.</p> <p>签证申请表：该表格可在线填写，网址为 <https://formulario-mre.serpro.gov.br>。每位申请人需单独提交一份申请表。填写完毕后，需打印并签字。</p> <p>请注意：签证申请表收据上的签名必须与申请人护照上的签名一致。此外，在填写在线表格时，所有原本以中文填写的信息（例如姓名、地址）必须使用拼音/拉丁字母输入，而非中文汉字。</p> <p>如申请人未满18周岁，父母/法定监护人需代为签署签证申请表 RER 回执</p>			
2.	<p>Original passport.</p> <p>The passport must be signed and have at least two blank visa pages. Previous passports, whenever available, are not essential documents, but their submission is encouraged as it can assist in the analysis by consular authorities;</p> <p>Please note: a minimum of six-month validity of the passport is not a requirement for issuing the visa, but is a common requirement by airline companies for those travelling to Brazil.</p> <p>原始护照。护照必须签名且至少保留两页空白签证页。过往护照虽非必需文件，但建议提交，因其有助于领馆进行审核分析；</p> <p>请注意：护照的有效期至少为六个月不是签发签证的要求，但这是航空公司对前往巴西的申请人的常见要求。</p>			
3.	<p>One recent photograph not older than 6 months, size 4cm x 5cm, in color, front view, white background.</p> <p>一张不超过6个月的近照，尺寸4cm x 5cm，彩色，正面，白色背景</p>			

4.	Certificate of criminal records issued within the past 90 days and duly apostilled. 过去90天内签发并经海牙认证的无犯罪记录证明。			
5.	Legal document which proves the relationship between applicant and his/her parents and its translation in Portuguese or English (e.g. Birth Certificate issued by hospital or Police; Hukou; relationship certificate or other equivalent legal document etc.). 证明申请人与其父母之间关系的法律文件及其葡萄牙语或英语翻译（例如医院或警察局签发的出生证明；户口本；关系证明或其他同等法律文件等）。			
6.	The articles of incorporation or bylaws of the religious institution headquartered in Brazil; 总部设在巴西的宗教机构的公司章程或细则；			
7.	Proof of legal representation powers of the religious institution headquartered in Brazil; 总部设在巴西的宗教机构的法律代表权证明；			
8.	A Proof by the entity headquartered in Brazil of maintenance and exit from the national territory; 总部位于巴西的实体提供的维持于和离开国家领土的证明；			
9.	A declaration of ordination or academic transcript or a statement from the religious institution qualifying the applicant for the religious activities to which he/she was assigned in the country or, in the case of a member of an institution of consecrated life, proof of this status; 一份受戒声明或学术成绩单，或宗教机构的声明，使申请人有资格参加他/她在该国被分配的宗教活动。或者，如果是奉献生活机构的成员，则应提供这一身份的证明；			
10.	A Curriculum vitae; 履历			
11.	When applicable, a declaration that the applicant will only perform activities in indigenous areas with express authorization from the National Indian Foundation (FUNAI). 在适用的情况下，声明申请人只会在国家印第安人基金会（FUNAI）明确授权的情况下在本地地区开展活动。			

Please note: applicants for visas granting stays longer than 90 days (VITEM) are strongly encouraged to obtain their Cadastro de Pessoa Física (CPF). The CPF is an essential registration number for conducting any civil or financial activities in Brazil.
