<p>1. Visa application form: The form is available online at <https://formulario-mre.serpro.gov.br>. A separate form must be completed for each applicant. Once filled out, the form should be printed and signed.</p> <p>Please note: The signature on the Visa Application Form Receipt – RER receipt must match the applicant’s signature on his/her passport. Additionally, when filling out the online form, any information originally in Chinese characters (e.g., names, addresses) must be entered using Pinyin/Latin letters, not Chinese characters.</p> <p>If the applicant is under 18 years of age, both parents/legal guardians must sign the Visa Application Form Receipt – RER on the applicant’s behalf.</p> <p>签证申请表：申请表可在 <https://formulario-mre.serpro.gov.br> 在线填写。每位申请人须单独填写一份。填写完成后，请打印并签名。</p> <p>请注意：签证申请表回执页（RER）上的签名必须与申请人护照上的签名一致。此外，填写在线表格时，原为中文的内容（如姓名、地址）必须以拼音或拉丁字母填写，不得使用中文字符。</p> <p>若申请人未满18周岁，须由父母或法定监护人共同在签证申请表回执页（RER）上签名。</p>			
<p>2. Original passport. The passport must be signed and have at least two blank visa pages. Previous passports, whenever available, are not essential documents, but their submission is encouraged as it can assist in the analysis by consular authorities;</p> <p>Please note: a minimum of six-month validity of the passport is not a requirement for issuing the visa, but is a common requirement by airline companies for those travelling to Brazil.</p> <p>护照原件。护照必须签名并至少有两页空白签证页。旧护照并非必需文件，但若可提供，建议一并提交，有助于领事部门审核。</p> <p>请注意：签证签发不要求护照至少六个月有效期，但航空公司通常要求旅客赴巴西时持有至少六个月有效期的护照。</p>			
<p>3. One recent photograph not older than 6 months, size 4cm x 5cm, in color, front view, white background.</p> <p>一张彩色近照（不超过6个月），尺寸为4厘米x 5厘米，正面照，白色背景</p>			
<p>4. Certificate of criminal records issued within the past 90 days and duly apostilled.</p> <p>由申请人当地公安机关近90天内出具的无犯罪记录证明，需经海牙</p>

5.	Legal document which proves the relationship between applicant and his/her parents and its translation in Portuguese or English (e.g. Birth Certificate issued by hospital or Police; Hukou; relationship certificate or other equivalent legal document etc.). 一份证明申请人与其父母关系的具有法律效力的文件，以及葡萄牙语或英语翻译件（例如：出生证、户口、亲属关系公证或其他同等法律效力文件）。			
6.	Health insurance that covers the applicant in Brazil; 在巴西有效的健康保险			
7.	Documents proving their status as a digital nomad, namely证明其数字游民身份的文件，包括： i. a declaration by the applicant certifying the ability to perform their professional activities remotely, using information and communication technologies; 申请人声明其具备利用信息与通信技术远程开展专业活动的能力； ii. an employment or service contract, or other documents proving a relationship with a foreign employer; and 就业或服务合同，或能证明与外国雇主存在雇佣关系的其他文件； iii. proof of means of subsistence from a foreign paying source, in a monthly amount equal to or greater than USD 1,500 (one thousand five hundred U.S. dollars), or availability of bank funds in the amount of USD 18,000 (eighteen thousand U.S. dollars). 证明来自境外支付来源的生活费用，月金额等于或高于1,500美元，或银行资金可用余额为18,000美元。			

Please note: applicants for visas granting stays longer than 90 days (VITEM) are strongly encouraged to obtain their Cadastro de Pessoa Física (CPF). The CPF is an essential registration number for conducting any civil or financial activities in Brazil.
