PROOF OF PURPOSE OF STAY - BUSINESS VISIT</p> <ul style="list-style-type: none"> - Visa applicants on business visit/commercial fairs/congress, invited by a legal person in the Republic of Croatia, shall enclose with the visa application a letter of guarantee by legal person as proof of the purpose of their visit, filled out by the guarantor – a legal person from Croatia. - The guarantor shall enclose with the letter of guarantee a document proving its liquidity ("Bon 1" or "Bon 2", or certificate of the commercial court that no liquidation proceedings have been initiated etc.). The letter of guarantee shall be signed by the person authorized to represent the guarantor. If the person authorized to represent the legal person is a citizen the EEA/Switzerland or a third-country national, he/she must have approved temporary or permanent stay in Croatia. The validity period of temporary stay of the citizen of the EEA/Switzerland or the third-country national must cover the period to which the applicant is invited. - If the purpose of the visit is to attend commercial fairs or congress organised by non-Croatian organizers, letters of invitation from the organisation of this events or invitations to attend them - original certificate of employment or equivalent from the company or organisation in Thailand – stating position, length of employment, salary, purpose and duration of the trip, and who will absorb the expense for the visit - trade fair entry tickets and an invitation stating purpose and duration of the trade fair, if relevant; - Any appropriate document indicating the accommodation envisaged or proof of sufficient means to cover the accommodation 	<input type="checkbox"/>	<input type="checkbox"/>
