Missing Document(s)	Type of document
	Cover letter completely filled on https://applyvisa.um.dk/ , printed and signed by the applicant.
	Visa Fee payment receipt printed from https://applyvisa.um.dk/
	The Original passport should be valid for at least 3 months beyond the intended duration of stay in the Schengen territory and with at least two blank page to affix the visa. The passport must have been issued within the last 10 years.
	Copy of previous visas and stamps of the applicant's old passport(s) <i>if any</i>
	VEVO (Visa Entitlement Verification Online) or other proof of re-entry permit for Australia valid for at least 3 months after the departure from the Schengen region (or a written explanation if you cannot document this)
	Proof of residential address in Australia (e.g. copy of driver licence, a utility bill, a bank statement or similar)
	If married or in a partnership, provide a marriage certificate or registered partnership agreement .
	<ul style="list-style-type: none"> • Documents from employer/company: • Letter from employer. Documentation from the employer regarding what kind of job/ profession the applicant has in the company and for how long he/she has been employed by the company, reason for the visit to Denmark/Schengen and monthly salary. • Company's registration • Documentation that shows the applicant's company is registered in the country. Specifications of in which line of business the applicant's company is registered.
	A signed invitation or Online invitation containing contact details of the inviting party; the applicant's identity; the purpose of the journey (meetings, conferences, training or business related events); and the period and place of intended stay.
	Proof of accommodation: Hotel reservations, rental of holiday home or campus residence reservation. If you intend to stay with a family member or a friend, proof of sponsorship and/or private accommodation from the host. If you are travelling to several Schengen states, proof of accommodation in each of them.
	Documentation of funds to cover the trip. Bank statement in Australia with applicant's name covering minimum last 3 months in applicant's name According to the Danish Immigration Service you must have the necessary means to pay for your stay and return trip. As a general rule, you must have at your disposal approx. DKK 350 per day. If you are staying in a private home and your host will cover all costs. If you are staying at a hotel, the amount must be greater, approx. DKK 500 per day. You can find further information https://www.nyidanmark.dk/
	Flight reservations of return or round ticket. If applicant is traveling to several Schengen states proof of intra-Schengen flight reservation, train itinerary or car rental. (Do not buy the ticket until a visa has been granted).
	Overseas travel medical insurance valid for all Schengen-countries. The insurance has to cover the applicant for at least 30,000 Euros or equivalent, for all risks e.g. accident, illness, medical emergency evacuation etc. The policy has to clearly specify the period of validity and has to cover the entire duration of the trip including the date of arrival & departure.

Note: A translation in English must be attached to any document, where the original is not in English.
