TOURIST VISA CHECKLIST

<input type="checkbox"/>	<p>Original Passport and one photocopy</p> <p>must be valid for another three months after conclusion of travel and must have two empty pages. Photocopies of all visas and immigration stamps for the last 5 years.</p>
<input type="checkbox"/>	<p>Two current biometric passport pictures</p>
<input type="checkbox"/>	<p>Visa application form</p> <p>completely filled out and signed by applicant</p>
<input type="checkbox"/>	<p>Details regarding the travel destination</p>
<input type="checkbox"/>	<p>Details regarding the means of travel for the outward - and return journey</p> <p>(details regarding the airline) no flight ticket needed</p>
<input type="checkbox"/>	<p>Hotel-voucher or confirmation of the hotel / guest house that the accommodation has already been paid for</p>
<input type="checkbox"/>	<p>Visa Fee (EUR 80.-)</p> <p>refer to waived and reduced visa fee list if applicable</p>
<input type="checkbox"/>	<p>Statement of account(s) of the previous six months with bank confirmation</p>
<input type="checkbox"/>	<p>Travel Health Insurance</p> <p>valid for the duration of the stay, minimum coverage of EUR 30,000. - valid for all Schengen States. PH THIs must be accredited (original & 1 photocopy), DE THIs can be submitted as photocopy, fax or scan.</p>
<input type="checkbox"/>	<p>If employed: Proof of employment (ITR, COE, Approved Leave of Absence)</p> <p>COE must include: employers full name, complete address, telephone number with area code, details regarding the position, income, employment duration.</p>

<input type="checkbox"/>	<p>If self-employed: proof of registration and commercial activity of the company (ITR, Bank certificates, company accounts, etc.)</p>
