VISIT VISA CHECKLIST

Document	Specifics
<input type="checkbox"/>	Original Passport and one photocopy must be valid for another three months after conclusion of travel and must have two empty pages. Photocopies of all visas and immigration stamps for the last 5 years.
<input type="checkbox"/>	Two current biometric passport pictures
<input type="checkbox"/>	Visa application form completely filled out and signed by applicant
<input type="checkbox"/>	Proof of relationship with the sponsor (e.g. birth- / marriage certificates, which substantiate the kinship) Written correspondence, telephone connections and other evidence of relationship between applicant and sponsor
<input type="checkbox"/>	If no formal obligation is submitted: An informal invitation letter by the host letter indicate host's exact address of residence, the purpose of travel and the full duration of travel and stay
<input type="checkbox"/>	Details regarding the means of travel for the outward - and return journey details regarding the airline, no flight reservation is needed
<input type="checkbox"/>	Visa Fee (EUR 80.-) refer to waived and reduced visa fee list if applicable
<input type="checkbox"/>	Statement of account(s) of the previous six months with bank confirmation
<input type="checkbox"/>	- OR -
<input type="checkbox"/>	Formal Obligation Original + 1 photocopy
<input type="checkbox"/>	Travel Health Insurance valid for the duration of the stay, minimum coverage of EUR 30,000. - valid for all Schengen States. PH THIs must be accredited (original & 1 photocopy), DE THIs can be submitted as photocopy, fax or scan
<input type="checkbox"/>	If employed: Proof of employment (ITR, COE, Approved Leave of Absence) COE must include: employers full name, complete address, telephone number with area code, details regarding the position, income, employment duration

<input type="checkbox"/>	If self-employed: proof of registration and commercial activity of the company (ITR, Bank certificates, company accounts, etc.)
<input type="checkbox"/>	- OR -
<input type="checkbox"/>	If you are a pupil/student: School / university certificate: proof of enrollment; if applicable: letter of exemption from studies

<input type="checkbox"/>	Proof of real estate property e.g. original land title (for validating photocopy), deed of sale

<input type="checkbox"/>	Personal appearance of both parents (if residing in the PH) during submission of visa application with valid ID	Valid ID: passport or driver's license *if the person(s) having custody over the child reside abroad, the declaration of consent must be given before a German (honorary-) consul, if residing in DE the declaration of consent must be given before the Aliens Authority
