8	Proof of advance payment of the treatment / financial arrangements with the medical doctor in Germany		
9	Correspondence between the sending medical doctor and the receiving medical doctor		
10	Proof of financial status:		
10a	If employed : Payslips of the last three months / employment contract		
10b	If self-employed : Certificate of Proprietorship or other proof of ownership (proof of land title, proof of income from agriculture (sales form) etc.)		
10c	Personal bank statement of the past three months with sufficient funds		
10d	Last three years Income Tax Return (ITR) form or Form 16 (Certificate of Income Tax deducted at the source of salary)		
11	Proof of accommodation for your entire stay in the Schengen area

guarantee that a visa is granted. Submission of incomplete documentation or refusal to appear for a special visa interview may result in the rejection of your application.
