Confirmation

I hereby confirm that I have been informed about and have understood the following:

- Entry into Germany is currently restricted due to the pandemic.

 The visa issued to me alone does not entitle me to enter Germany.
- With the visa issued to me, entry to Germany is only permitted if I present a recognized proof of a complete protective vaccination against the coronavirus SARS-CoV-2 (proof of vaccination) upon entry.
- The conditions that the proof of vaccination must fulfill have been explained to me.
- In particular, I am aware that the underlying full protective vaccination must have been given with one or more vaccines listed by the Paul Ehrlich Institute on the Internet at https://www.pei.de/impfstoffe/covid-19 and that at least 14 days must have passed since the last required vaccination.
- For convalescents to demonstrate complete vaccination status, there must be evidence that SARS-CoV-2 coronavirus disease was present prior to vaccination. A positive PCR test must be submitted as proof of this disease.
- Following the amended definition of "proof of vaccination" in § 2 No. 10 CoronaEinreiseV and § 2 No. 3 SchAusnahmV, reference is made in the following with regard to the requirements for complete vaccination protection to the recently updated specifications of the Paul Ehrlich Institute (see further: www.pei.de/impfstoffe/covid-19), according to which applies:
 - For complete vaccination protection, vaccination with two doses is necessary in all cases.
 - Even in cases where the vaccine from Johnson & Johnson (Jannssen-Cilag) has been used for basic immunization and which should initially be carried out by means of a single vaccination dose, a second vaccination has recently become necessary for complete vaccination protection. According to the specifications of the Paul Ehrlich Institute, this can be done either with the vaccine from BioNTech or Moderna.

Exceptions, which justify a complete vaccination protection already with a single vaccination dose, exist in the following cases, if the person concerned:

- can demonstrate a specific positive antibody test performed on him or her, and that test was performed at a time when the individual had not yet received vaccination against COVID-19,
- o can prove that he/she has been infected with the coronavirus by means of a PCR test, provided that this test was carried out at a time when the person concerned had not yet received vaccination against COVID-19,
- o has undergone infection with the coronavirus after receiving a single dose of vaccine. PCR test evidence is required to prove infection.
- You are advised that you should obtain current PEI guidance well in advance of any travel. Guidelines
 may change depending on the scientific status and thus also result in changes in the possibilities of
 entry.
- Proof of vaccination must be in English, French, German, Italian or Spanish.
- The exact requirements for proof of vaccination, which allow entry to Germany despite the pandemic-related entry restrictions, can be found on the Internet at https://www.bmi.bund.de/SharedDocs/faqs/DE/themen/bevoelkerungsschutz/coronavirus/coronavirus-faqs.html, there under "IV. Reisebeschränkungen im außerereuropäischen Luft- und Seeverkehr (Einreisen nach Deutschland aus einem Drittstaat)" and "Welche Anforderungen werden an den Impfnachweis gestellt?".

- Persons who have not yet reached the age of twelve and have not yet been vaccinated may enter Germany with proof of testing (PCR test or antigen test) accompanied by at least one fully vaccinated parent. Persons who have not yet reached the age of six do not require proof of testing.
- If I am unable to present a recognized proof of vaccination, I will not be allowed to enter Germany and will be turned back at the German border. In addition, carriers, especially airlines, may deny my transportation to Germany from the outset.
- If I am turned back at the border upon arrival at a German airport, the airline will transport me back to my point of departure and may hold me liable for any costs incurred as a result.
- The decision on my entry into Germany will be made by the officials responsible for border police control only upon arrival at a German airport or border.

I also confirm that

- 1. will have received a complete protective vaccination against the coronavirus SARS-CoV-2 (as described above) before entering Germany; and
- 2. will present an approved proof of vaccination (as described above) upon entry.
