

Tourist Visas and Visas for visiting family or friends

Required documents

| Presented | Document | Remarks |

| | Passport | The passport must be signed by the holder, it must have been issued within the last 10 years, it must have at least one free page and it must be valid for at least 3 months after the end of the planned trip. |
| | Signed application form | VISACODEX online form available on the VFS website. Parents must sign for minor children. |
| | Passport photo | Information about biometric passport photos is available here: https://tinyurl.com/y7lcjv5k |
| | Passport copy | Passport copies of the applicant's parents must also be submitted if the applicant is a minor. |
| | Copy of residence permit | Only for non-Omanis. The Omani residence permit must be valid for at least 1 month after the end of the planned trip and must be in the current passport. |
| | No objection letter by the applicant's sponsor in Oman | Only for non-Omanis. The letter must state the salary of the employee and since when they have been working for the employer. |
| | Proof of accommodation | All hotel reservations (in German or English, not Arabic) OR signed invitation letter + passport copy by the host in Germany |
| | Flight reservation | |
| | Health insurance + copy | The insurance must be valid for the whole Schengen area and cover at least 30.000€. |
| | Personal bank statement | The bank statement must show the last 6 months and must not be older than 2 weeks (Online print-out statements need to be stamped by the bank). If somebody else is sponsoring the trip, a sponsor letter (with signature), the sponsor's bank statement and the sponsor's passport copy (with signature) have to be submitted. Alternatively, an <u>original</u> 'Formal Obligation' (Verpflichtungserklärung) + copy can be submitted. |
| | Proof of family ties and economic existence | Only for Yemeni applicants and residents of Yemen. Employment contract, proof of income, commercial or business registration, property documents, civil status documents like marriage certificate and birth certificates of the applicant's children (documents must be translated into German or English) |
| | Visa fee | 80€ for applicants over 12 years old, 40€ for children between 6 and 11 years old. Must be paid in OMR according to the current exchange rate. |
| | Data Protection Information | Received : (Signature of Applicant) |

For **family members of German citizens** (spouses, minor children and parents of minor children), the visa application is free of charge. Proof of relationship to the German citizen (birth certificate/marriage certificate + their passport copy) must be provided in addition to the above listed documents.

Family members of other EU citizens (their spouse; both of the spouses' relatives in the descending line who are under the age of 21 or are dependent; both of the spouses' relatives in the ascending line who are dependent on the EU citizen) only need to submit the application form, passport, passport copy, a copy of their Omani residence permit and copies of their parents' passports (for minor applicants). However, this exception only applies if they are travelling together with the EU citizen or visiting them. Proof of relationship to and, if applicable, dependency on the EU citizen must be provided (their passport copy, birth/marriage certificate, proof of dependency).

To be signed if the documents are not complete:
