Checklist – B2 Business, Conference, Medical Treatment & Short-term Study Visa

	Documents to be submitted for all types of visits:	Submitted
1.	Visa Application Form – fully filled and signed by the applicant, with personal mobile number, email address included.	
2.	Current passport (valid for at least 6 months) and older passports (if you have them with you). The current passport should have at least (1) blank page.	
3.	Copies of the current and old passport excluding the blank pages.	
4.	Two clear personal photos with a white background, sized 5cm x 5cm.	
5.	Last six months of Bank Statement, in which the name of the applicant appears clearly with original bank stamp. If Business Owner, please also attach copy of Company Bank Statements (for last six months).	
6.	If employee – last six months' Salary Slips	
7.	In case of Divorce, child custody documents or a letter from the court in respect of the child is required.	
8.	Children under 18 years must have parent's signatures on the Minor Consent Form.	
9.	Overseas Travel Insurance with COVID-19 coverage included	
10.	Vaccine Certificates (required) for both doses or 03 doses	
11.	Proof of property or home rental contract	
12.	Copy of family book (if applicable)	
13.	Isolation & Quarantine Form filled and signed by the applicant	
14.	Flight and Hotel bookings	
15.	National ID and Emirates ID (if applicable)	
16.	<p>Business Visits:</p> <ul style="list-style-type: none"> • An official invitation from the Israeli company including the inviting company's name and logo, the name of the invited person, the mission details, duration of stay, place of residence, and the inviter's personal details (personal ID number, the company's phone number, mobile number, and signature). • If the applicant owns a company, please provide a registration certificate of the company from your country's authorities, in which your name appears as the owner. • If you are an employee in the company, please provide a valid official letter from your employer in English, stating your position in the company and explaining the visit's purpose. 	

17.	Medical Treatment: <ul style="list-style-type: none"> • A formal invitation from the hospital with the treatment's dates. • Reports from Doctor where the applicant is currently residing. • Place of residence in Israel (full address and phone number). 	
18.	Student Visa: <ul style="list-style-type: none"> • Presenting of a study voucher • A certificate proving that you have completed the previous school year in Israel. • Presenting a proof of financial ability to finance studies, and resuscitation of the whole time of studies in Israel. • A document indicating the date of graduation for the current year • Application for a visa - signed and printed. 	

Note:

All applicants submitting a request for a Visa have to fill the online form (in the link given below) in order to receive an automatic Online Entry permit letter.
