CHILDREN (18 at the moment of submission of demand for N.O.) WISHING

| 1 | <p>Application form fully completed and signed by:</p> <ul style="list-style-type: none">• The applicant (if he\she turned 18 after the application for family reunion was filed by the inviting parent)• Or the father/mother of the applicants (in case the parents are not both in Italy)• The legal guardian of the applicant (in case both his/her parents are in Italy) <p>The visa application should be directly filed by the applicants, parents, legal guardians (not by an agent). Those people, identified with a valid photo ID document, should duly sign the form at the moment of its submission.</p> |
| 2 | <p>Two recent (no more than 6 months) passport-size photographs (white background)</p> |
| 3 | <p>Passport/Travel Document must:</p> <ul style="list-style-type: none">a) Have been issued within the previous 10 years, and the validity must not exceed 10 years.b) At least have a validity of 3 months after intended stay.c) Have at least 2 blank pages. <p>Passport must be issued within the jurisdiction of the Consulate.</p> |
| 4 | <p>“Nulla Osta” (or its reference number), issued by the competent S.U.I. in Italy. Kindly note that the “Nulla Osta” is valid only for a period up to six months from its date of issue. The “Nulla Osta” will have to be renewed on expiry. <u>Discrepancy, if any, in the details of the applicant on the “Nulla osta” should be corrected to correspond with the passport’s data.</u> If not done, the Consulate will request correction to the competent S.U.I. in Italy and the visa application will remain pending at the Consulate until the required correction is received.</p> |
| 5 | <p>Original attested copy of the passport (all pages) of the inviting person who has applied for the “Nulla Osta” in Italy. It is advisable also to provide an attested copy of the old passport of the inviting person if available. Attestation may be done at the Italian Comune, Tribunale, Notaio. If both parents are resident in Italy then the attested passport copy of both the parents is required.</p> |
| 6 | <p>Original attested copy of “Permesso di soggiorno” (Permit of stay) of the inviting person who has applied for the “Nulla Osta” in Italy. If the permit of stay is expired and under renewal then copy of the renewal receipt must be also attested. If both parents are resident in Italy then the attested copy of "Permesso di soggiorno" (Permit of stay) of both parents and or its attested renewal receipt must be submitted.</p> |

| 7 | <p>Birth Certificate of the child/children in original, issued by the Registrar of Births and Deaths, attested by the local Authorities and verified by the Under Secretary, Home Department and apostilled by the Ministry of External Affairs, along with translation in Italian legalised by the Italian Consulate (for India).</p> <p>For Nepal the Birth certificate shall be attested by the Ministry of Foreign affairs and legalised by the Italian Consulate, along with its translation clearly mentioning the registration number.</p> |
| 8 | <p>Affidavit from parent in India giving his/her consent to the child travelling to Italy for family reunion with the parent residing in Italy.</p> <p style="text-align: center;">OR</p> <p>If both parents are resident in Italy then a "dichiarazione" equivalent to the "affidavit" has to be made in Italy and then attested by the Italian competent authority. Please note that the 'dichiarazione' should clearly mention the person entrusted with the task of being the legal guardian of the minor in India in the absence of the parents.</p> |
| 9 | <p>If both the parents are in Italy, NO objection certificate from the local legal guardian is required (duly apostilled affidavit) plus ID document of the local guardian.</p> |
| 10 | <p>Although not compulsory, applicants may decide to share pictures portraying them with the inviting parent and any other document deemed useful in order to strengthen the application.</p> |

* PLEASE NOTE: The Consulate reserves the right to request for further documentation and to verify the documentation submitted. In this case the maximum period of 90 days fixed by the Italian law for the evaluation of this visa type will be suspended till verification is completed
