**REQUISITE DOCUMENTS FOR FAMILY REUNION VISA OF PARENTS  
OF INDIANS RESIDING IN ITALY.**

<b>1</b>	<b>Application form</b> fully completed and signed by applicant. The visa application should be <b>directly filed by the applicants</b> (not by an agent). Applicants, identified with a valid photo ID document, should duly sign the form at the moment of its submission.
<b>2</b>	<b>Two recent</b> (no more than 6 months) <b>passport-size photographs</b> (white background)
<b>3</b>	<b>Passport/Travel Document must:</b> a) Have been issued within the previous 10 years, and the validity must not exceed 10 years. b) At least have a validity of 3 months after intended stay. c) Have at least 2 blank pages. Passport must be issued within the jurisdiction of the Embassy/Consulate
<b>4</b>	<b>“Nulla Osta” (or its reference number), issued by the competent S.U.I. in Italy.</b> Kindly note that the “Nulla Osta” is valid only for a period up to six months from its date of issue. The “Nulla Osta” will have to be renewed on expiry. <u>Discrepancy, if any, in the details of the applicant on the “Nulla osta” should be corrected to correspond with the passport’s data.</u> If not done, the Consulate General will request correction to the competent S.U.I. in Italy and the visa application will remain pending at the Consulate until the required correction is received.
<b>5</b>	<b>Original attested copy of the passport (all pages) of the inviting person</b> who has applied for the “Nulla Osta” in Italy. It is advisable also to provide an attested copy of the old passport of the inviting person if available. Attestation may be done at the Italian Comune, Tribunale, Notaio.
<b>6</b>	<b>Original attested copy of “Permesso di soggiorno” (Permit of stay) of the inviting person</b> who has applied for the “Nulla Osta” in Italy. If the permit of stay is expired and under renewal then <b><u>copy of the renewal receipt</u></b> must be also attested.
<b>7</b>	<b>Original Birth Certificate</b> of the son/daughter residing in Italy, issued by the Registrar of Births and Deaths, <b>attested</b> by the local Authorities and verified by the Under Secretary, Home Department and <b>apostilled</b> by the Ministry of External Affairs, along with translation in Italian <b>legalised</b> by the Italian Consulate ( <b>for India</b> ). For <b>Nepal</b> the Birth certificate shall be <b>attested</b> by the Ministry of Foreign affairs and <b>legalised</b> by the Italian Consulate, along with its translation clearly mentioning the registration number.

8	<p><b>Affidavit from parents stating their economic conditions and the names of all their children (boys and girls), their date of birth and their current place of residence.</b> The affidavit must be attested by:</p> <ul style="list-style-type: none"> <li>• the Notary Public;</li> <li>• Sub-Divisional Magistrate or Deputy Commissioner in the place where the certificate was issued;</li> <li>• Home Secretary of State and <b>then duly apostilled</b> by the Ministry of External Affairs, Govt. of India.</li> </ul>
9	<p><b>Proof of “dependency”</b> A parent is considered fully dependent on the inviting son/daughter in Italy according to the following criteria:</p> <ul style="list-style-type: none"> <li>• If less than 65 years of age, only if he/she has no other kids residing in India;</li> <li>• If more than 65 years of age, only if the other kids in India cannot support him/her due to serious health problems which must be duly proved with medical certificates and documents.</li> </ul> <p>Proof of remittance of money for a reasonable period of time (before the demand for N.O. was submitted) from the family member in Italy is required. Kindly provide original bank account passbook of the applicant/s and remittance certificates from Italy (mandatory) and India. Official documents should also be submitted in case the parents own property in India and are receiving any income thereof.</p>

The Consulate reserves the right to request for further documentation and to verify the documentation submitted. In this case the maximum period of 90 days fixed by the Italian law for the evaluation of this visa type will be suspended till verification is completed.
