	him/her due to serious health issues which must be proved with documents.						
	Remittance of money for a reasonable period of time from the family member in Italy is required.						
	Kindly provide original bank account passbook of the applicant/s and remittance certificates from						
	Italy (mandatory) and India. Official documents should also be submitted in case the parents own						
	property in India and are receiving any income thereof.						

NOTE: Visa fees are not applicable if the parents are able to prove they fully depend financially on the inviting person.

This Embassy reserves the right to ask for a Personal Interview or Additional Documents, whether required.

APPLICANTS SHOULD NOTE THE FOLLOWING:

☐ All the documents should be provided in original and copy. Original documents will be returned to applicants while copies will be kept with the visa application. No photocopy will be accepted, except the photocopy of the identity card or passport of the inviting party residing in Italy;

☐ Any forged or fake certificate/affidavit/passport submitted will not be returned to the applicant who might be prosecuted in both the Italian and the Indian Courts.
