THE APPLICATION WILL BE ACCEPTED <u>ONLY</u> IF THE DOCUMENTS AT POINTS n. 6, 7 AND 8 ARE SUBMITTED.

Kindly be informed that students whose admission is subject to an <u>entrance test</u> at the University in Italy will need to apply for a <u>LongTerm</u> (D) Visa. However, students who are supposed to take an entrance test before their final study certificate is issued will apply for a <u>Short Term</u> (C) Visa.
