4.	Overseas medical insurance with minimum coverage of Euro 30,000- for emergency hospital and repatriation expenses. (Photocopy)								
5.	Travel itinerary with travel dates, including a return flight reservation or ticket (Please mention if any other country/countries are to be covered during the entire Trip).								
6.	Two set photocopy of Applicant's Passport.								
7.	Proof of social or professional status : <ul style="list-style-type: none">• Evidence of working/ business activity or evidence of source of income.• Leave authorization from the employer.• Salary slips
