1)	Schengen Application Form - Completed visa application signed by the applicant; - Applications of minors must be signed by both parents.			
2)	Two recent passport-size colored photographs Full face on white background, one photo attached to application.			
3)	Current Passport and Previous passports (if any) - Passport must have at least two blank pages; - Passport must be valid for a period of at least 3 months after the date of departure; - Copy of current and previous Passport bio-data page.			
4)	Letter of Invitation/Declaration - To be completed by Italian/EU national according to Italian Immigration regulations; - To be accompanied by a copy of the Italian/EU national's passport and Identity card.			
5)	If the direct ascendants do not demonstrate that they are dependent on the inviting EU citizen child, they will also have to present a travel, medical and accident insurance policy as per travel itinerary (cover of at least € 30,000).			
6)	Family bond Proof a) Marriage Certificate (spouse joining) - The Marriage Certificate, translated into Italian or English and duly legalized either by the Embassy of Italy in Colombo or by the MoFA b) Birth Certificate (child sponsored by parent / parent sponsored by child) - In both cases, the birth certificate of the child is mandatory. Sri Lankan birth certificates must be translated into Italian or English, and duly legalized either by the Embassy of Italy in Colombo or by the MoFA. Alternatively you may choose to submit an original Italian Birth Certificate.			

Please note:

- TOURISM FAMILY MEMBERS OF EU CITIZENS VISA is free of charge **SOLELY** for the following family member: (a) spouse of EU citizen (or civil union partner); (b) Direct descendants (children) of EU citizen under 21 years of age; (c) Direct ascendants (parents) of EU citizen provided they can prove financial dependency on their EU citizen child.

Direct descendants (children) of the EU citizen, **over 21 years of age**, or **parents** of the EU citizen, **provided they can prove financial dependency** on their child

- The Embassy reserves the right to request further documentation if and when required;
- All documents should be provided in original accompanied with a set of photocopies in A4 size;
- Documents in Sinhalese, Tamil or any other language must be presented with an official English or Italian translation and must be legalized by the MoFA and/or the Embassy of Italy in Colombo. In case of non-Sri Lankan nationals, documents must be certified by the respective Embassy / High Commission / Consulate based in Colombo.
