- Students enrolling to a university course (Laurea, Laurea Magistrale, Diploma accademico di primo livello e Diploma Accademico di secondo livello, corsi accademici AFAM) must apply for a visa by **November 30th 2026**, even if they are attending classes online.

2	<input type="checkbox"/>	One passport size color photo, white background, maximum 6 months old (see specifications)
3	<input type="checkbox"/>	A valid passport (and a copy) satisfying the following criteria: <ul style="list-style-type: none">○ its validity must be at least three months longer then the visa requested;○ it must contain at least two blank pages;○ it must have been issued within the previous 10 years;○ it must hold a valid UAE visa.
4	<input type="checkbox"/>	Copy of a valid UAE Residence Visa, issued by any “Northern Emirates” authority.
5	<input type="checkbox"/>	Previous Schengen, USA, or UK visa copy, if any;
6	<input type="checkbox"/>	Admission letter confirming the pre-enrollment released by the UNIVERSITALY portal;
7	<input type="checkbox"/>	Proof of sufficient means of subsistence: minimum €10.179,85 per year. In order to comply, the applicant must provide the following: <ul style="list-style-type: none">○ If not financially independent<ul style="list-style-type: none">a NOC from parents stating their commitment to financially support the student for the whole duration of stay (along with copy of passport and UAE visa of the sponsoring parent)b Supporting relative guarantees:<ul style="list-style-type: none">i Salary Certificate, Title of Deed in the UAE, etc.ii Last 3 months bank statements of supporting relative’s account in the UAE;○ If financially independent:<ul style="list-style-type: none">a Own salary certificate and NOC issued by local employer, along with copy of signatory ID or passport);b Last 3 months bank statements of personal account in the UAE; <p>Note: Online bank statements or copies will be accepted only with original bank stamp. Only financial resources located in the UAE will be deemed valid Only relatives’ (up to 4th grade, to be proved by family status certificate) financial support will be deemed valid.</p>
8	<input type="checkbox"/>	Proof of the availability of the financial means needed for repatriation (in addition to point 7).
9	<input type="checkbox"/>	Proof of a suitable accommodation in Italy (Campus accommodation, rental agreement or a confirmed hotel booking of at least 30 days). In case of an accommodation in a private house, the owner must provide the Declaration of Hospitality Form duly signed in front of a notary public.
10	<input type="checkbox"/>	An international insurance policy with full and unlimited coverage for hospitalization during the entire stay in Italy. Detailed table of benefit must be provided. Only individual policies will be considered, no family, group or company policies are accepted. If the University is providing a Medical Insurance, applicant must then provide a medical insurance limited to the first month. If insurance certificate was issued abroad, a declaration issued by the relevant Italian Consulate/Embassy stating its validity in Italy is needed.

13	<input type="checkbox"/>	<p>If the course will be taught in Italian, adequate knowledge of Italian language must be attested by University in the enrollment form:</p> <ul style="list-style-type: none">• B1 minimum for any foundation course;• B2 minimum for any other course (Laurea, Diploma, etc). University certification <p>if the course (any course: Laurea, Diploma, etc). will be taught in English to non mothertongue student, B2 level minimum certified by an internationally recognized institution (e.g. TOEFL, IELTS, etc).</p>
14	<input type="checkbox"/>	Proof of payment of enrollment fee, if any;
15	<input type="checkbox"/>	<p>If the student is a minor, parents must appoint a custodian in Italy for the whole time student will be underage. In order to do so, parents must provide the following documents:</p> <ul style="list-style-type: none">• A declaration released in front of a notary public in the UAE, mentioning full details of the person to be appointed as custodian. The person must be legally resident in Italy. The declaration must be legalized by MOFA and then translated in Italian by a Legal Translator (for a list of translators click here).• A declaration of the custodian in Italy in which he clearly agrees to be appointed. The signature of the custodian must be legalized by an Authority in Italy (i.e.: Comune or Prefettura). A copy of an ID of the custodian must also be provided. <p>Refer to <u>checklist Common Guidelines for details.</u></p>

Any original document must be delivered in a separate envelope, that will be returned. Copies have to be provided in the application.

I also understand that if the visa is granted, within eight working days from the arrival in Italy, students must apply for the Permit of Stay ("Permesso di soggiorno") to the relevant Police Headquarter ("Questura"). The form must be filed through authorized Post Offices (*Sportello Amico*), using the relevant kit available there. Following to that, the student will receive an invitation letter with details of the appointment scheduled by the Police Headquarters. The day of the appointment 2 pictures will be required.
