

Required Documents for purpose of travel:

Applicants of Lithuanian Origin – Visa Application Centre in Saint-Petersburg

1. Harmonized visa [application form](#) completed and signed by the applicant.
2. **Travel document** valid for at least three months after the intended date of (last) departure from the Schengen area, containing at least two blank pages and issued within the previous ten years.
3. One **colour photo**. Actual (made no earlier than 6 months ago), size - 3.5 x 4.5 cm, printed on photo paper. The face must occupy 70-80 % of the area, the face from the chin to the upper head should occupy 31-36 mm. The background is white and monochrome.
4. **Visa fee** (for family members only) in line with the Annex 2.
5. **Travel medical insurance** covering the entire period of intended stay (in cases of multiple entry visa – covering the entire period of the first trip), valid for all Schengen States and covering any expenses which might arise in connection with repatriation for medical reasons, urgency medical attention, emergency hospital treatment or death during the stay. The minimum coverage must be €30.000.
6. **Copy of the internal passport** (issued at the age of 14): pages concerning the applicant's bio data, and registration in Russia.
7. In cases of minors:
 - i. **Copy of the birth certificate.**
 - ii. **Consent of the parental authority** or legal guardian should be required only if the minor travels alone or with one parent/legal guardian..
 - iii. **Copy of the valid Schengen visa of the parent(s)** travelling with the minor for whom a visa is not applied at the same time with the parent(s).
8. In cases of third-country nationals, **proof of legal residence in the Russian Federation** in line with federal legislation (residence permit), valid for at least three months after the planned return from the Schengen area or a **document proving that the applicant has applied for a renewal** of proof of legal residence. If not resident, proof of legal presence in the Russian Federation and justification for submitting visa application in the Russian Federation instead of the country of residence.
9. **Attested documents or certificate attesting to the Lithuanian origin** issued by a consular post

OR

Corresponding birth certificates, attesting to the Lithuanian origin

10. For family members – **proof of relationship**.

Persons retaining their right to Lithuanian citizenship and their family members

1. Harmonized visa [application form](#) completed and signed by the applicant.
2. **Travel document** valid for at least three months after the intended date of (last) departure from the Schengen area, containing at least two blank pages and issued within the previous ten years.

3. One **colour photo**. Actual (made no earlier than 6 months ago), size - 3.5 x 4.5 cm, printed on photo paper. The face must occupy 70-80 % of the area, the face from the chin to the upper head should occupy 31-36 mm. The background is white and monochrome.
4. **Visa fee** (for family members only) in line with the Annex 2.
5. **Travel medical insurance** covering the entire period of intended stay (in cases of multiple entry visa – covering the entire period of the first trip), valid for all Schengen States and covering any expenses which might arise in connection with repatriation for medical reasons, urgency medical attention, emergency hospital treatment or death during the stay. The minimum coverage must be €30.000.
6. **Copy of the internal passport** (issued at the age of 14): pages concerning the applicant's bio data, and registration in Russia.
7. In cases of minors:
 - i. **Copy of the birth certificate**.
 - ii. **Consent of the parental authority** or legal guardian should be required only if the minor travels alone or with one parent/legal guardian..
 - iii. **Copy of the valid Schengen visa** of the parent(s) travelling with the minor for whom a visa is not applied at the same time with the parent(s).
8. In cases of third-country nationals, **proof of legal residence in the Russian Federation** in line with federal legislation (residence permit), valid for at least three months after the planned return from the Schengen area or a **document proving that the applicant has applied for a renewal** of proof of legal residence. If not resident, proof of legal presence in the Russian Federation and justification for submitting visa application in the Russian Federation instead of the country of residence.
9. **Certificate of the retained right to Lithuanian citizenship**.
10. For family members – **proof of relationship** (if not inscribed in certificate of the retained right to Lithuanian citizenship).

Persons travelling to attend a funeral of a close relative, or to visit a seriously ill close relative

1. Harmonized visa [application form](#) completed and signed by the applicant.
2. **Travel document** valid for at least three months after the intended date of (last) departure from the Schengen area, containing at least two blank pages and issued within the previous ten years.
3. One **colour photo**. Actual (made no earlier than 6 months ago), size - 3.5 x 4.5 cm, printed on photo paper. The face must occupy 70-80 % of the area, the face from the chin to the upper head should occupy 31-36 mm. The background is white and monochrome.
4. **Visa fee** (for family members only) in line with the Annex 2.
5. **Travel medical insurance** covering the entire period of intended stay (in cases of multiple entry visa – covering the entire period of the first trip), valid for all Schengen States and covering any expenses which might arise in connection with repatriation for medical reasons, urgency medical attention, emergency hospital treatment or death during the stay. The minimum coverage must be €30.000.

9. **Documents proving the necessity of their travel on humanitarian grounds** (they usually are sent to the Embassy by competent authority of The Republic of Lithuania). In such cases consultation with the Embassy is required.
10. **Proof of relationship.**

Family members of Lithuanian citizen

1. Harmonized visa [application form](#) completed and signed by the applicant.
2. **Travel document** valid for at least three months after the intended date of (last) departure from the Schengen area, containing at least two blank pages and issued within the previous ten years.
3. One **colour photo**. Actual (made no earlier than 6 months ago), size - 3.5 x 4.5 cm, printed on photo paper. The face must occupy 70-80 % of the area, the face from the chin to the upper head should occupy 31-36 mm. The background is white and monochrome.
4. In cases of minors:
 - i. **Copy of the birth certificate.**
 - ii. **Consent of the parental authority** or legal guardian should be required only if the minor travels alone or with one parent/legal guardian..
 - iii. **Copy of the valid Schengen visa of the parent(s)** travelling with the minor for whom a visa is not applied at the same time with the parent(s).
5. **Copy of a passport of Lithuanian citizen.**
6. **Proof of relationship.**
