

Schengen Visa for VISIT

1. **Schengen visa application form**, fully completed and signed by the applicant.
2. **Original valid passport or travel document**. It must be valid at least 3 months beyond the end of the intended visit. It must be issued within the previous 10 years and have at least 2 blank visa pages.
3. If applicable, copies of previous Schengen visas issued within the past 5 years.
4. **One recent passport photo** (35x45 mm) in color with white background, taken within the last six (6) months. Side photos, digital files and photocopies will not be accepted.
5. **Original proof of residency in the USA**, e.g. a valid residence permit (aka: green card) or valid US resident visa: A, E, F plus endorsed I-20 by competent authority, G, H, I, J plus J1 documents, L, O, R. The US residence permit or visa should be valid at least three months beyond the intended departure from the territory of the Schengen area.
6. **Proof of confirmed (fully paid) flight reservation or other proof of intended transport and a full travel itinerary** (if several Schengen countries will be visited or if the trip covers several Schengen countries and non-Schengen countries).
7. **Letter of invitation** from the **host**. **The letter must be submitted electronically** through the Lithuanian Migration Information System [MIGRIS](#).
8. **Proof of accommodation**. Evidence of hotel bookings or travel plan for the entire stay in the Schengen area: confirmed hotel reservations, stating your full name, address and telephone number of the hotel, including confirmation number. If the information regarding accommodation is included in the letter of invitation, the applicant does not have to submit addition proof of accommodation.
9. **A recent reference letter from your employer** (including your position, salary and duration of employment) **or school** (confirming your enrollment). The letter must be printed on the official company letter, signed, stamped and dated. If self-employed, an original or a notarized copy of a business license.
10. If requested, a valid visa in your travel document for the country you are visiting after leaving the Schengen area.
11. Proof of **sufficient financial means**:
 - **bank statements from the last 3 months**, listing your full name and address;
 - **proof of regular income** e.g. pay slips of the **last 3 months**.If self-employed, tax return from previous fiscal year or proof of previous economic activity and of an income during previous fiscal year;
If retired, copy of pension certificate or a letter of previous employer or a pension check stub or confirmation from the responsible authority about the amount of pension;
If a third party is providing financial support to the applicant, e.g. a friend or a relative, documents to show they have sufficient financial resources to support the applicant.
12. **A letter** from your **insurance company** and a copy of your insurance card, with **your name, dates, coverage area, confirming international coverage** of at least **30.000 EUR (Euros)** (around USD 40,000) for each of the following items:
 - **Emergency medical expenses;**
 - **Emergency hospital treatment;**
 - **Repatriation for medical reasons;**
 - **Repatriation of mortal remains.**The insurance must cover the entire period of an intended stay and be valid in all Schengen countries.
13. If the applicant is a minor and travels without parents or with one parent:
 - if travelling with one parent: written consent certified by public notary of the other parent or the legal guardian, except in cases of a parent having sole custody or guardianship of the minor.
 - if travels alone (without parents): written consent, certified by a public notary, of both parents or legal guardians.
14. If you wish to collect your passport by mail: applicants applying at visa centers must provide a Fedex envelope.
