Please submit this checklist with your application.

Immigration New Zealand reserves the right to request additional information in the course of assessing an application.
紐西蘭移民局有權在申請審理過程中要求申請人遞交補充文件。

From September 3, 2018, please prepare your documents in accordance with the following document specifications when submitting your visa application via New Zealand Visa Application Centre in Taipei (VAC). The VAC will scan all your documents to the New Zealand Immigration and keep all your documents for one month except original passport. Please retrieve your documents after one month. You may choose to submit only a copy of the document, but it is recommended that the original be submitted with the photocopy (the original will be returned immediately).

- **All documents must be A4 size.**
- **Any documents which are smaller or larger than A4 size, must be photocopied onto A4 sized paper. This includes the pages of any previous passports.**
- **All documents must be free from any staples, clips or pins before they are submitted.**
- **Torn, crumpled or heavily creased documents cannot be scanned and therefore must be photocopied onto A4 sized paper before they are submitted.**
- **Documents should not be laminated.**

自 2018 年 09 月 03 日起，在台灣遞交簽證申請者，請依照下列文件規格準備您的文件。台北簽證申請中心會將您的所有文件掃描上傳至紐西蘭移民局，並保留您的所有文件一個月，屆時請您取回所有文件。您可以選擇僅遞交文件的影本，但建議正本連同影本一併遞交（正本會立即歸還）。

- 所有文件必須為 A4 尺寸，且為一般白色影印紙，不得使用廢紙。
- 所有大於或小於 A4 尺寸的文件，皆須影印成 A4 規格，包括舊護照的每一頁（適用於欲提供舊護照者）。
- 所有文件不得使用訂書針、迴紋針或是圖釘裝訂。
- 撕裂、起皺或有摺痕的文件無法掃描，必須重新影印成 A4 規格。
- 文件不可護貝。

Participants in the New Zealand Trade and Enterprise or New Zealand Tourism Board's Visiting Media Programme (VMP) from countries on the [visa waiver list](#) may be granted a visitor visa and entry permission on arrival in New Zealand. They are permitted to undertake employment directly associated with their invitation under the VMP for one month from their date of arrival. If your country is not on the visa waiver list, you must apply for a visitor visa before travelling to New Zealand. Applicants who intend to stay for more than 1 month must apply for a work visa.
凡參加由紐西蘭貿易發展局或紐西蘭旅遊局所舉辦的媒體計畫訪問(VMP)之活動成員，若來自免簽國家者，將可直接進入境紐西蘭，並於入境時取得旅遊簽證的入境權。他們並可憑藉該 V M P 會員所核發的邀請函於該單位工作，時間為期由入境日起算一個月。而來自非免簽國家之成員，需在入境紐西蘭前申請觀光簽證，欲停留紐西蘭超過一個月者需申請工作簽證。
