IMPORTANT! All applicants must hand in the **printed and signed VISA APPLICATION FORM**, and **RECEIPT (unless exemption from visa fee)** from the application portal when submitting the application. The Minors need to be signed by parents or legal guardians.

<p>One passport photo: Not older than six months (color, 4x5cm, white background). The photo must not be edited.</p> <p>一张护照照片: 6 个月内 (彩照, 4x5cm, 白色背景), 不能修图。</p>			
<p>Original invitation letter signed by the sponsor/reference person stating the purpose and duration of the visit, and the relation with the applicant (Not older than 6 months).</p> <p>邀请信原件: 邀请人或邀请方亲笔签名的邀请信, 需注明访问目的、停留时间以及与申请人的关系 (邀请信需在 6 个月内出具)。</p>

<p>Proof of relationship with sponsor/reference person.</p> <ul style="list-style-type: none"> • For family visit: Notary certificate of family relationship (i.e. marriage certificate, birth certificate whichever is applicable), legalized by Chinese relevant authority. Original + 1 copy. • Letter of employment from parent(s) or legal guardians • If the minor is traveling alone or with only one parent, notary certificate of permission to travel from both parents or legal guardians, legalized by Chinese relevant authority. <p>Proof of solvency: Bank statement from the last 3 months.</p> <ul style="list-style-type: none"> Retired persons: Retirement certificate or proof of pension or other proof of regular income. Unemployed and married: letter of employment and income of the spouse and notary certificate of marriage, legalized by Chinese relevant authority . Original+1 copy Unemployed and not married: Documents showing other source of income For Minors travelling alone: Bank statement and signed payment statement (in English) from parent(s) or legal guardians (no notarization). <p>偿付能力证明: 最近 3 个月的银行对账单。</p> <ul style="list-style-type: none"> 退休人员: 退休证明或养老金证明或其他固定收入证明 无业且已婚人员: 配偶的在职证明和收入证明, 需经中国有关部门认证的结婚证公证书, 原件和 1 份复印件 无业且未婚人员: 提供其他收入证明 单独旅行的未成年人: 提供父(母)或法定监护人的银行对账单及签字的同意支付费用声明 (英语, 无需公证) <p>Or,</p> <p>Proof of sponsorship and/or of private accommodation form filled out and signed by the sponsor in Norway. Or a completed Invitation Form 241011 filled out and signed by the sponsor in Sweden. <p>Passports: new and old. New passport valid at least 3 months after expiry of visa, containing minimum two blank pages and issued within the previous ten years. Copy of bio data page in the passports (old and new).</p> <p>护照: 新旧护照, 新护照要求在签证有效期后仍有不少于 3 个月有效期, 包含至少 2 页空白页, 且近 10 年内颁发的。护照复印件: 新旧护照的个人信息页复印件。</p>	
<p>Huko: Copy of all used pages (no translation). Only for Chinese nationals. For other nationals: Copy of valid Chinese residence permit.</p> <p>户口簿: 所有信息页复印件(无需翻译), 仅针对中国公民。 外国公民需提供有效的在华居住许可证复印件。</p>	
<p>Travel medical insurance for the duration of the stay in the Schengen area with a minimum coverage of EURO 30.000.</p> <p>旅行医疗保险: 保险需涵盖在申根地区全部停留时间, 保险金额至少为 30.000 欧。</p>	
<p>Power of Attorney -Optional for applicants who want others to represent/assist them in the case. 委托授权书 (可选, 如果申请人想授权他人协助或查询申请)</p>
