<p>Passports: New passport valid at least 3 months after expiry of visa, containing minimum two blank pages and issued within the previous ten years. Copy of bio data page in the new passport. If a new passport has been issued within the last year, please submit the original old passport or the photocopy of the identity page and all pages with stamps and visas in the old passport.</p> <p>护照: 新护照要求在签证有效期后仍有不少于 3 个月有效期, 包含至少 2 页空白页, 且近 10 年内颁发的。新护照的个人信息页复印件。</p> <p>如果您的新护照在过去一年内签发, 请提交旧护照原件或者该旧护照身份页及所有包含出入境章和签证的各页复印件。</p>		
<p>Hukou: Copy of all used pages (no translation). Only for Chinese nationals. For other nationals: Copy of valid Chinese residence permit.</p> <p>户口簿: 所有信息页复印件(无需翻译), 仅针对中国公民。</p> <p>外国公民需提供有效的在华居住许可证复印件。</p>		
<p>Flight reservation for Round-trip to China and the trips in Schengen area. Should not be bought before visa has been issued.</p> <p>机票预订单: 往返中国及整个申根地区间的机票预订单, 机票应在签证颁发后出票付款。</p>		
<p>Proof of accommodation: Detailed Hotel reservations for the whole duration of the intended stay in Schengen area.</p> <p>住宿证明: 提供整个申根地区停留期间的酒店预订单详情。</p>		
<p>Travel medical insurance for the duration of the stay in the Schengen area with a minimum coverage of EURO 30.000.</p> <p>旅行医疗保险: 保险需涵盖在申根地区全部停留时间, 保险金额至少为 30.000 欧。</p>		
<p>Power of Attorney, Optional for applicants who want others to represent/assist them in the case.</p> <p>委托授权书 (可选, 如果申请人想授权他人协助或查询申请)</p>
