Passport/Travel document and Identification	Valid for minimum three month after the departure from the Schengen region, with at least two blank pages and issued within the previous 10 years.	
	Valid original passport – must have at least two blank pages.

	Original residence card.	
	Copies of all used pages of current and former passports, as well as copy of Residence Card.	
Purpose of Travel	Signed invitation from person in Norway, including explanation of relation, reason for visit and planned activities.	
	Proof of relation to inviting person in Norway, i.e. birth certificate, pictures, chat logs, etc.	
	Copy of passport and, if not Norwegian citizen, residence card of the person inviting.

Financial means *You must submit one of more of listed documents.	Original UDI Proof of sponsorship and/or of private accommodation form – can be downloaded from the UDI website.	
	Bank statement or bank book in applicant's name – total amount at least equal to 500NOK per day of visa's validity + copy of front page, page showing name of account holder and page showing current funds

Multiple entry *Only if you are applying Multiple Visa	Documented to show the frequent travel record to Norway over the last year.
