- All fees are paid online but Embassy's fees for certain Danish applications must be transferred to the bank account of Norway Embassy in Beijing in NOK (Norwegian Kroner) referring to the information below. The payment receipt needs to have information about the customer's name, date of birth and passport number. The receipt (copy) has to be submitted along with application at the Norway Visa Application Centre in Seoul.

모든 수수료는 온라인 상 결제하실 수 있으며 일부 덴마크 신청서 중 부과되는 대사관 수수료는 베이징 주재 노르웨이 대사관 계좌로 아래의 정보를 통해 노르웨이 크로네 (NOK)로 입금 후 입금 영수증 (사본)을 신청서 접수시 센터에 제출하여 주십시오. 이체 영수증 상에는 본인 성함, 생년월일 그리고 여권 번호가 명시되어 있어야 합니다.
