1	<p><b>Application form duly completed and signed</b></p> <ul style="list-style-type: none"> <li>Fully completed in Portuguese or English and signed and dated by the applicant</li> <li>For minors both parents must sign the application form and visit application center for submission</li> </ul>		
2	<p><b>One recent passport size photograph</b></p> <p>Requirements:</p> <ul style="list-style-type: none"> <li>should not be older than 6 months + in colour with white background + 3,5 by 4,5 cm</li> </ul>		
3	<p><b>Passport / travel document</b></p> <p>Must:</p> <ul style="list-style-type: none"> <li>have a validity of at least 3 months after the intended stay</li> <li>be issued within the previous 10 years</li> <li>have 2 blank pages</li> <li>it is recommended to attach previous passports (if applicable)</li> </ul>		
4	<p><b>Non Iranian Nationals residing in Iran</b></p> <ul style="list-style-type: none"> <li>Iranian Resident Permit valid for at least 3 months after expiry of the requested visa</li> </ul>		
5	<b>Flight reservations</b>		
6	<p><b>Invitation letter bearing the name <i>Termo de Responsabilidade</i> form or a hotel reservation</b></p> <p>The <a href="#"><i>Termo de Responsabilidade</i></a> must:</p> <ul style="list-style-type: none"> <li>be signed by the host and certified by a public notary in Portugal together with a copy of the host EU identity card or EU passport or residence card</li> <li>if the inviting person (the host) is to cover the applicant's expenses it is recommended to provide evidence of possession of sufficient financial resources to cover the intended stay (e.g. signed and stamped bank statements for the last 3 months or last the last 3 payslips)</li> <li>if the host is to cover accommodation it is recommended to be provided either a copy of a mortgage contract or a rental contract + a Certificate of Residency issued by the <i>Junta de Freguesia</i> in Portugal</li> </ul> <p>The hotel reservation must:</p> <ul style="list-style-type: none"> <li>be confirmed for the entire stay</li> </ul>		
7	<p><b>Travel medical insurance</b></p> <p>Must:</p> <ul style="list-style-type: none"> <li>cover the entire territory of all Schengen Member States with a minimum coverage of 30.000,00 € (euros) for medical expenses</li> <li>cover expenses that might arise in connection with repatriation for medical reasons, urgent medical attention, emergency hospital treatment or death during stay. A certificate policy is mandatory</li> </ul>		
8	<p><b>Employees (*)</b></p> <ul style="list-style-type: none"> <li>Letter addressed to "Embassy of Portugal in Tehran", dated not later than one month with the company's letterhead stating employment status, position, length of contract and salary (or recent employment contract). The letter should also be duly stamped with the name and position of the signatory, specify the dates of approved leave and state the purpose of visit + Payslips for the last three months (3 last payslips) + Certificate of affiliation to Tamin-e Ejtemaei (Social Security Organisation) + Khadamat-e Darmani (Health Services Organisation) or equivalent, or letter of the employer explaining why this certificate is missing</li> </ul> <p><b>Traders (*)</b></p> <ul style="list-style-type: none"> <li>Proof of entry in the trade register (e.g. trade licence or declaration from official trade organisation) and proof of membership of Tamin-e Ejtemaei (Social Security Organisation), Khadamat-e Darmani (Health Services Organisation) or equivalent, if applicable</li> </ul> <p><b>Directors or shareholders of Iranian companies (*)</b></p> <ul style="list-style-type: none"> <li>Introduction letter signed by a legal representative of the company confirming the office or status of the applicant; proof of existence of the company in Iran (e.g. notice published on the Official Journal); proof of appointment if not mentioned on the Official Journal</li> </ul>

8	<b>Artists (*)</b> <ul style="list-style-type: none"> <li>Proof of membership to one of the artist's official professional associations (e.g. House of Cinema, House of Photography, etc.) and/or proof of previous engagement in professional artistic activity (exhibitions, festivals, etc.) and certificate of affiliation to Tamin-e Ejtemaei (Social Security Organisation), Khadamat-e Darmani (Health Services Organisation) or equivalent</li> </ul> <b>Pensioners (*)</b> <ul style="list-style-type: none"> <li>Proof of receipt of a retirement pension</li> </ul> <b>Students or minors (*)</b> <ul style="list-style-type: none"> <li>Evidence of the parents' social or employment status and, where applicable, school attendance certificate or student card</li> </ul>		
9	<b>Minors (*)</b> <ul style="list-style-type: none"> <li>If travelling alone or with one parent (legal representative), minors are requested to present a declaration from the other parent that he/she can travel abroad certified by a public notary</li> <li>An identity document, bearing the parents' signature (1 document for each parent)</li> </ul>		
10	<b>Bank account statement for the last 3 months</b> <ul style="list-style-type: none"> <li>Has to show financial transactions/circulation of the money in the account for the last 3 months</li> </ul>		
11	<b>Proof of ownership of property in Iran (if applicable) (*)</b>		
12	<b>Official translation of birth certificate (Shenasnameh) (*)</b>		
13	<b>Copy of the passport and previous visas</b>		

**PLEASE NOTE: Pointers (\*) all the documents presented must be officially translated to Portuguese or English language and attested by both Ministry of Justice and Ministry of Foreign Affairs.**

The Embassy of Portugal in Tehran reserves the right to request further documentation if deemed necessary, may call the applicant for an interview. False or falsified documents, including fake bookings, will lead to the refusal of visa and/or further consequences.
