3	A copy of the national ID card with English translation		
4	Travel insurance

6	Proof of financial support to cover stay: - the applicant's signed and stamped bank statements for the last 6 months /or a sponsoring letter with bank statement from the sponsor.		
7	Proof of economic ties, such as: (Please note that the below documents are not mandatory but recommended to include)		
7.1	- stamped bank statements		
7.2	- proof of property ownership		
7.3	- proof of company ownership		
7.4	- <u>for employees</u> : certificate of employment specifying the date of recruitment, position in the company, salary level, leave permission and contact details of employer.		
7.5	- <u>for pupils/students</u> : Proof of enrolment in school/university.		
8	Proof of personal ties in Iraq		
8.1	- an extract from the family register, a marriage certificate if applicable		
8.2	- copies of ID cards for the spouse and children.		
	Family and friends visit – additional documents that must be provided:		
9	Invitation		
10	Copy of referent's passport/ Residence permit card/ ID card		
11	Proof of accommodation for the duration of the stay (confirmed hotel reservation). If not staying with a host.		
12	If relatives are invited proof of kinship is required, such as: Marriage certificate, birth certificate, extract of family record .		

	Tourism – additional documents that must be provided:		
8	Detailed travel plan for the entire trip		
9	Hotel booking		
	Business visit – additional documents that must be provided:		
8	Invitation from host company/organiser including the host's contact info, official stamp, letterhead, and legible signature		
9	Documents showing business connections between the two parties such as: <ul style="list-style-type: none"> - contract, payments of invoices, a list of orders, e-mail correspondence between the business partner sent from their official e-mail address. 		
10	<ul style="list-style-type: none"> - the Iraqi company's business licence or chamber of commerce certificate if applicable. 		
	Minor applications – additional documents that must be provided:		
8	If a minor travels without parents: an original notarised statement of consent from both the parents /legal guardian.		
9	If a minor travels with only one parent: an original notarised statement of consent from the other parent.		
	Official visit – additional documents that must be provided:		
8	A letter from the relevant Iraqi government/public body confirming that the visit has been approved and confirming the professional position of the applicant		
9	Note verbale from the Iraqi Foreign Ministry with names and position of each component of the delegation		
10	A copy of official invitation and of the program of visit if applicable
